The Hon'ble High Court of Himachal Pradesh has passed an order dated 16.12.2009 in criminal appeal No. 436/09 which was accompanied with an application for condonation of delay in filing the appeal. From the perusal of the order dated 16-12-2009 passed by the Hon'ble High Court in Cr. A. No.436/09 it is noticed that though the Hon'ble Court was pleased to condon the delay in filing the appeal but at the same time the Hon'ble Court has observed/directed as under:-

## C r.M.P. (M) No. 1064/2009

Though, we are not satisfied with the grounds stated for condonation of delay, which are stereotype because in every case where condonation is sought on behalf of the state, explanation given is that a particular Department took a long time to give its opinion or that the record received from the prosecutors or the concerned Department was incomplete etc., yet in the interest of justice and also keeping in view the fact that the delay is only of six days, we allow the application and condone the delay. Application is disposed of.

We order that in future every application for condonation of delay sought by the state shall be accompanied by the affidavit of the Principal Secretary of the concerned Department, so that, at least it comes to the notice of the Principal Secretary of that Department how his Department functions.

Learned Additional Advocate General shall obtain a copy of this order and shall ensure that the copies are sent to the Principal Secretaries of all the Departments with a forwarding letter of the learned Advocate General.
