Subject:- Appointment of sons/daughters/near relations of Government servant who die in harness leaving his family in immediate need of assistance - Modification thereof.

- 1. In order to ensure functional efficiency and to avoid unnecessary delay at all level(s) in relation to cases of compassionate employment, it has been decided that only the cases complete in all respects, after ascertaining their feasibility under the relevant provision(s) of policy of the Government framed in this regard be sent to this Department. Special attention should be given to:
 - a) Finance Department's CHECKLIST containing 06 format(s) for ascertaining indigence of the applicant as per Department of Personnel's instruction(s) dated 24.08.2002 & 02.09.2002 which can be downloaded from the official website of Finance Department from its "Expenditure Link";
 - b) restriction of 5% quota of the vacancies of direct recruitment in a cadre arising in a calendar year only, as per Department of Personnel's OFFICE MEMORANDUM No. Per.(AP-II)-F-(4)-4/89-VI dated 10th November, 2008 be also imposed strictly. Thus, the Department(s) henceforth will have to maintain a waiting list of eligible compassionate cases with them and as and when any point within this 5% ceiling gets vacated, the same will be filled up by the first person available in the waiting list. In the waiting list, the seniority of decided cases shall be determined on the basis of date of death of the Government employee in whose place compassionate employment is being sought.

- 1. As per Notification No. GAD(CC)-5-2/71 dated 04.09.2013, the subject matter regarding "All policy matters relating to formulation/amendment in the existing policy of providing employment assistance to the dependents of the deceased Government servants including issue of instructions as and when required and providing of employment assistance to the eligible dependents thereunder" has been allotted to FINANCE DEPARTMENT vide Serial No. 29 of the Business of the Government of Himachal Pradesh (Allocation) (144th Amendment) Rules, 2013.
- In order to gear-up the efficiency in administration vis-à-vis to make the existing compassionate employment policy more practicable & employee-friendly, a new provision is henceforth added in Para-2 "To whom the Policy is applicable" in the Department of Personnel's Office Memorandum No. Per.(AP-II)-F-(4)-4/89 dated 18.01.1990 as under:-
 - "(f): The compassionate employment in case of natural death shall be permissible to the eligible dependents of only those deceased Government employees who died in harness on or before attaining the age of 50 (Fifty) years.

However, in relation to dependents of those employees who died in job related accidents or were killed in action during the course of employment, this age limit will not be applicable."
