Shimla.

Regarding appointment of ex-officio Vigilance Officer in the
Departments.

Sir

I am directed to invite your attention to this department letters No. Per (Vig) F-11 (EO VCC)-2/2003 dated 23-09-2004 followed by reminders dated 15-10-2004 and 16-1-2004 and letters of even number dated 21-02-2006 and 23-09-2006 vide which instructions have been issued for appointment of ex-officio Vigilance Officer in each Department and for quarterly reports on the progress of vigilance cases/complaints departmental enquiries, as envisaged in the Vigilance Manual. However, it has been noticed that only a few Departments have appointed ex-officio Vigilance Officer after getting approval of this Department and are sending quarterly reports. In order to comply with the provisions of the Vigilance Manual, it is absolutely necessary that ex-officio Vigilance Officer is appointment in each Department. Therefore, in order to streamline the procedure and early appointment of ex-officio Vigilance Officer by all Departments, it has now been decided that the Secretaries concerned will at their level appoint an officer of the Department concerned as ex-officio Vigilance Officer for their Department. However, before such appointment, it may be ensured that the officer is a senior officer, capable of handing vigilance work effectively and the integrity of such an officer beyond doubt.

You are, therefore, requested kindly to take further action in the matter accordingly and furnish the name, designation and telephone number of the ex-officio Vigilance Officer so appointed. The Departments in which the ex-officio Vigilance Officer has already been appointed will also furnish their name, designation and telephone number within a week's time to this department.
