Subject:- Regarding grant of bus purchase permission in respect of contract carriage permit (All India Tourist Permit)

Sir,

Pursuant to the decision taken in the State Transport Authority meeting held on **24.02.2020** vide Agenda Item No. **5** on the applications received for the grant of All India contract carriage permit in respect of bus (es), it is *intimated* that the applicants as per the list enclosed have been accorded sanction to purchase buses with a condition to register BS-IV vehicles before **31.03.2020** and to obtain contract carriage permit, on the following conditions:

- 1. The body shall be fabricated in accordance with Chapter V of the Central Motor Vehicle Rules, 1989 read with chapter VII of H.P. Motor Vehicle Rules 1989.
- 2. That the model purchased by the operator must be approved by the Department of Transport Himachal Pradesh.
- 3. As per orders of Hon'ble Supreme Court in Writ Petition (Civil) No. 13029 of 1985 dated 24<sup>th</sup> October, 2018 new vehicle conforming to emission Standard Bharat Stage-VI shall be <u>sold or registered in the entire country w.e.f.</u> 01.04.2020. So, owner of the vehicle may ensure registration of BS-IV vehicle before 31.03.2020 in all respect.
- Ministry of Road Transport and Highways letter <u>No. RT-11016/16/2018-MVL dated</u> 4<sup>th</sup> February, 2020 shall be complied with, before registering the vehicles.
- 5. Specified fares or rates of fares shall be charged and a copy of the fare table shall be exhibited on the vehicle;
- 6. The specified standard of comfort and cleanliness shall be maintained in the vehicles;
- 7. That permit shall have mention of the following specifications:

- 8. That plying of the vehicle or carrying of passengers shall not be refused;
- That the owner shall comply with provisions of Motor Vehicles Act, 1988, Central Motor Vehicle Rules, 1989, H.P. Motor Vehicle Rules, 1999 and H.P. Motor Vehicle Taxation Act, 1972/Rules as amended from time to time;
- That the owner shall be required to pay all taxes levied by the Government on motor vehicles in the State from time to time.
  - That the STA/RTA may, after giving notice of not less than one month-
    - a) Vary the conditions of the permit
    - b) Attach to the permit further conditions
- 12. That the permit holder shall cause to be prepared in respect of each trip a list in triplicate of tourists to be carried in the vehicle, giving full particulars as under:
  - a) Name of the passenger
  - b) Address of the passenger
  - c) Age of the passenger

- d) Starting point and the point of destination
- 13. One copy of the list referred to in sub-rule(1) shall be carried in the tourist vehicle and shall be produced on demand by the officers authorized to demand production of documents by or under the provision of the Act and the Rules, and the second copy shall be preserved by the permit holder;

14. That the tourist vehicle shall either commence its journey, or end its journey, circular or otherwise, in the home state, subject to the condition that the vehicle shall not remain outside the home State for a period of more than three months. The permit holder shall see that every return of the tourist vehicle to the home State is reported to the authority which issued the permit. Provided that where the contracted journey ends outside the home State, the vehicle shall not be

offered for hire within that State or from the State to any other State except for the return to any point in the home state.

- 15. That the tourist vehicle may operate circular tours of places lying exclusively in the home State and outside the State if such circular tours are in the list approved by the Tourist Department of the home State to visit places of tourist, historical or religious importance and the tour is duly advertised beforehand.
- 16. That the permit holder of his authorized agent shall issue a receipt to the hirer and the counterfoil of the same shall be kept available with him and produced on demand to the officers empowered to demand documents by or under the Act;
- 17. That the tourist vehicle shall not be parked on any Bus Stand used by Stage Carriages and shall not operate from Bus Stand;
- 18. That the tourist vehicle shall be painted in white colour with a blue ribbon of five centimeters width at the center of the exterior of the body and the word "Tourist" shall be inserted on two sides of the vehicle within a circle of sixty centimeters diameters;
- 20. That the permit holder shall not operate the tourist vehicle as a stage carriage;
- 21. That the permit holder shall maintain a day-to-day logbook indicating the name and address of the permit holder and the registration mark of the vehicle, name and address of the driver with the particulars of his driving license and the starting and destination points of the journey with the time of departure and arrival and the name and address of the hirer;
- 22. That the permit holder shall furnish once in every 3 months the information contained in condition (10) to the State Transport Authority which granted the permit and the logbook shall be preserved for a period of 3 years and shall be made available to the said authority on demand along with the records referred to in conditions (2) and (4);
- 23. That the driver shall have a valid driving license;
- 24. That the owner will ensure that all safety requirements are adhered to meticulously. In case the vehicle meets with an accident because of the fault of the driver/owner, the permit shall be liable to be cancelled.
- 25. That the passenger list carried by the bus covered under All India Tourist Permit must have passport size picture of the passenger travelling in the bus, pasted against the name of the passenger.
- 26. The violation of any of the above conditions will render permit liable to be cancelled.
- 27. As the validity of grant letter so issued by you will be valid for 9 months only which can further be extended for 3 months by the concerned Secretary, RTA on payment of Rs. 1000/-. After 12 months no grant letter shall be extended.
- 28. Special care to be taken to register commercial vehicle on c/o address as it is noticed that tax recovery is difficult in cases of default in payments.
